The course work on the academic discipline "Sociology of conflicts and wars in the context of transformations and modernizations" is an individual task that is performed during the mastering of this discipline. The course work is carried out in accordance with the specified recommendations and requirements, in the time specified by the lecturer, is prepared by the student during one semester, in parallel with the study of the course. Course work belongs to the cycle of professional training, its status is mandatory. It is planned to prepare 30 hours of independent work (1 ECTS credit).

The purpose of the coursework in the discipline "Sociology of conflicts and wars in the context of transformations and modernizations" is the formation of students' abilities as future professionals:

- Ability to identify, diagnose and interpret social problems of Ukrainian society
 and the world community (PC02);
- Ability to use tools for conflict risk assessment and early prevention of conflicts in different spheres of life and at different levels of interaction of social subjects (PC10);
- determine the level of escalation of the conflict and the possibility of intervention in the conflict and choose its method (PC11).

According to the requirements of the educational program, after completing the coursework, students must demonstrate the following learning outcomes:

- analyze social phenomena and processes using empirical data and modern concepts and theories of sociology (PL01);
- apply relevant sociological theories of conflict, peacemaking and mediation, as
 well as the results of sociological research to solve contemporary social
 problems and conflicts; use methods of conflict resolution and mediation
 procedures in the socio-political sphere (PL12).

The maximum value of the coursework rating is 100 points; quality of course work - 50 points, quality of defense - 50 points.

The quality of the course work is evaluated:

48<50 points, if the work has a research character, contains a well- explained theoretical base, in-depth analysis of the researched topic, a critical review of sources and literature, is characterized by a logical, consistent presentation of the material with appropriate justifications and conclusions, performed in compliance with the basic requirements of the State Standard of Ukraine.

43<48 points, if the work is of a research nature, contains a sufficiently detailed analysis and critical review of scientific sources on the researched topic, is characterized by a consistent presentation of the material with appropriate, but not always substantiated conclusions, performed in compliance with the basic requirements of the State Standard of Ukraine.

38<43 points, if the work is of a research nature, contains references to sources, a consistent presentation of the material with conclusions, but not always substantiated, performed mostly in accordance with the requirements of the State Standard of Ukraine.

33<38 points, if the research of the problem provided for by the topic of the work is reduced to stating facts, gleaned from scientific sources without their critical analysis, contains a superficial analysis with unsubstantiated conclusions, is characterized by an inconsistent presentation of the material, performed with non-compliance with the basic requirements of the State Standard of Ukraine.

30<33 points, if the work has a weakly expressed research character, does not contain an independent analysis, substantiated conclusions, a critical understanding of scientific sources, is characterized by an inconsistent presentation of theoretical

material, is performed in non-compliance with the basic requirements of the State Standard of Ukraine.

20<30 points, if the work is not research in nature, does not contain independent analysis, substantiated conclusions, critical understanding of scientific sources, is characterized by an inconsistent presentation of theoretical material, is performed in violation of the basic requirements of the State Standard of Ukraine.

1<20 points, if the work is not an independent study of the topic, performed with the missing study of scientific sources, does not meet the requirements of the State Standard of Ukraine. Such work is returned to the student for revision.

The quality of protection is evaluated:

48<50 points, if during the defense of the work the student demonstrates deep knowledge of the issues of the topic, freely operates with research data, easily and convincingly answers the question.

43<48 points, if during the defense of the work the student demonstrates knowledge of the topic, freely operates with research data, without particular difficulties and convincingly answers the question.

38<43 points, if during the defense of the work the student demonstrates knowledge of the issues of the topic, freely operates with research data, without particular difficulties, but does not convincingly answer the question.

33<38 points, if during the defense of the work the student demonstrates a certain knowledge of the issues of the topic, operates, however weakly, with research data, unconvincingly answers the question with effort.

30<33 points, if during the defense of the work the student weakly demonstrates certain knowledge of the issues of the topic, does not operate with research data, answers unconvincingly and not to all the questions asked.

20<30 points, if during the defense of the work the student does not demonstrate knowledge of the topic, does not operate on research data, answers unconvincingly and not to all the questions asked.

1<20 points, if during the defense of the work the student does not demonstrate knowledge of the topic, does not operate on the research data, does not answer the questions.

The defense of the course work ends with the presentation of the total score, converting it into a grade and entering it into the record.

Transferring the value of rating grades from the coursework to ECTS for posting them to the Campus and the credit book is carried out in accordance with Table 1.

Preparation for writing, writing and defense of the work are aimed at forming students' modern theoretical and methodological ideas about the conflict and its varieties, its history, forms; learn the specifics of conflict in certain spheres and states of war and peace. Familiarize yourself with the main tools of the negotiation process and the formation of cooperative behavior at the micro- meso - macro levels of the socio-economic and political system. Independent understanding and analysis of

conflicts and their settlement, which corresponds to the current state of social sciences and socio-political practices.

The student chooses the topic of the term paper from the list of topics presented by the teacher, and can also propose his own topic after agreeing with the teacher. The student can write the term paper only on the topic agreed with the teacher.

Study results, control measures and deadlines are announced to students at the first lesson.

The title page of the term paper should have the following content: name of the university; name of the faculty; name of the department; registration number, name of academic discipline; topic of course work; surname and first name of the student, course, number of the academic group, supervisor, year.

The title page is followed by a detailed plan of the course work, in which the introduction, 3 sections of the main content, their subdivisions, conclusion, and list of used literature should be highlighted. The page numbers at the beginning of each question are indicated in the plan on the right. Each chapter starts on a new page.

The volume of the course work, depending on the chosen topic, can vary from 25 to 30 pages of the main text (upon agreement with the teacher). The scope of the course work is determined by the student's ability to concisely and at the same time comprehensively reveal the topic: to show the importance of the issue under consideration, to evaluate how it is covered in special literature and solved in practice, to draw conclusions and justify one's own proposals.

Mandatory requirement: clear reference to sources of information. All numbers, facts, theories, opinions of scientists, quotes must have references in the form of [2, p. 54] (the first number means the number of the source in the list of literature given at the end of the creative work, and the second number is the number of the page in this source). It is advisable to use tables, diagrams, graphs, charts, etc. The list of used literature (at least 20 sources) is drawn up in accordance with the current rules. If the information is taken from the Internet, it is necessary, as for ordinary literature, to indicate the author, the title of the article, and then provide the website address on the Internet.

The course work is evaluated according to the following criteria: the logic of the plan; completeness and depth of topic disclosure; availability of illustrations

(tables, drawings, diagrams, etc.); the number of sources used and the clarity of references to them; display of practical materials and statistical data; design; justification of the student's own opinion on this issue in the form of a conclusion.

Deadline for submitting coursework for review: 10 days before the beginning of the credit session.

Course work is checked for plagiarism. If academic dishonesty is detected, the work is canceled and not checked.

The procedure for contesting the results of assessment control measures

Students have the opportunity to raise any issue relating to the screening process and expect it to be dealt with in accordance with pre-defined procedures. In order to appeal the control measures, the student must submit an application, in which the reason for the appeal should be indicated, and the facts of the teacher's bias should be given. The teacher must discuss this application with the student personally at the consultation. In the event of a lack of understanding regarding the result of the control measure, a commission is formed from the teachers of the department, which evaluates the procedure for conducting the control measure and the student's claims. The commission may decide to conduct the control measure again or reject the application. The commission's decision is final and cannot be appealed.
